# **Budget & Financials: Nancy-Anne Potts**

- The expectation is an operating surplus of 200K for the year.
- We will need to work on substitute cost for next year.
- Lunch program review for next year
- Club supplies, revenue and expenses offset each other.
- Field trip net even
- Sales tax will be given back, however it has been delayed.
- Haven't been given what the allocations will be for the new school year.

Scott Owens / Nancy-Anne Potts: The vacant property tax is running about 60K a year. We need to look at the actual value of the land. Attorney Bowen sent correspondence on recouping the 60K in property taxes. It would cost a great deal to up fit from past information. Attorney Bowen suggested getting three names and the cost to appraise the land.

Dr. Joseph will research with a pro bono mechanic to get estimates on the buses. The two large passenger busses need repairs and the mini buses are due for general maintenance. Bus number 125 is not worth the repairs that are needed per Mr. Credle.

## **Lunch: Tonya Hunt**

We are looking at two companies the Spicy Green and Chicken Hut. Waiting to get the final cost from both and the menu of what the lunch options will be, based on the parent survey.

# **Insurance: Nancy-Anne Potts**

The cost of the insurance is going up about 50% to 60%. We are looking for dual options. Tonya Hunt asked if we could look at building our HAS plan? For now Nancy-Anne Potts will be doing more research on what our final options will be.
